## Rajeev Dubey

Rajeev Dubey has recently retired from the Chairmanship of three Mahindra Companies (Mahindra First Choice Wheels, Mahindra Insurance Brokers and Mahindra Steel Service Centre) and from the Governing Body of the International Labour Organization (ILO), Geneva where he was also the Employers' Vice President of the Asia Region.

He was earlier the Group President (HR & Corporate Services) & CEO (After-Market Sector), Member of the Group Executive Board, Mahindra & Mahindra Ltd. till 1st April, 2020.

He joined Mahindra in 2004, after a career spanning 29 years in the Tata Group, which he joined in 1975 as a member of the TAS. He spent 21 years with Tata Steel, and the next 7 years as CEO first of Tata Metaliks and then of Rallis India.
